Mr. Eways called for any Board and Officer nominations for the reorganization. No new nominations were heard. Mr. Adams made a motion to reappoint the same Board members and Officers in the same capacity as well as reappointing Ms. Wingenroth. Mr. Eways seconded the motion and it was unanimously approved. The Officers and positions are as follows:

A motion to approve the minutes for the August 27, 2019 meeting was made by Ms. Wingenroth, seconded by Mr. Adams and unanimously approved.

As outlined in Section 4.1 of the Bylaws pertaining to the annual report, Mr. McKeon referred to the financial statements forwarded to the Board with the agenda and the Profit and Loss and Balance Sheet covering January through month-end November 2019. In addition, the statement disclosing the names of the current officers and directors were reviewed.

A copy of the Conflict of Interest Policy was previously provided to the members, Executive and Deputy Directors. Annually, the Policy must be reviewed and the acknowledgment must be executed confirming their review.

A motion was made to transfer \$200,000. from the SEI account to the Authority's general checking account to cover expenses and to wire \$49,895.70 to The Bank of New York Mellon in January 2020 for the Airport HUD loan payment. Mr. Jenkins made the motion, seconded by Mr. Adams and it was unanimously approved.

A motion to approve and advertise the 2020 Meeting Schedule was made by Mr. Adams, seconded by Mr. Firely and unanimously approved. A copy of the Meeting Schedule is attached hereto.

Mr. Setley was reappointed as the BCIDF Solicitor for 2020. His annual retainer of \$12,500 covers the BCIDA general issues and the routine BCIDF issues. Mr. Adams made the motion, seconded by Mr. Jenkins and it was unanimously approved.

There being no further business to come before the Board, on motion by Mr. Adams and seconded by Mr. Firely, the meeting was adjourned at 8:40 AM.
