The TEFRA Hearing was held pursuant to the requirements of the Federal Tax and Fiscal Responsibility Act of 1982 and the Pennsylvania Open Meeting Law, 65 Pennsylvania Statutes 261-269. Any interested person from the public was invited to attend and to comment on the project.

The principal terms of the financing project were reviewed, including:

Name of Applicant:	Heritage Campus Green Hills LLC (the "Borrower")
Address of Project:	200 Tranquility Lane, Cumru Township, Berks County, Shillington, PA 19607

Total Cost of Project: Approximately \$56,000,000.00

Total Amount of Tax-Exempt Issue: Not to exceed \$25,000,000.00

Project Description: Proceeds of the financing will be used to refinance previously issued debt that financed the acquisition, construction and equipping of 50 personal care and 20 memory care senior living units (collectively, the "Project") owned by the Borrower and operated by its affiliate, Heritage Campus Green Hills Opco LLC, a Delaware limited liability company, for health care purposes, known as The Heritage of Green Hills, and located at 200 Tranquility Lane, Shillington, Cumru Township, Berks County, Pennsylvania.

The TEFRA Public Hearing was adjourned at 8:35 AM.
